With reference to the above cited subject, I have the honour to report to you as follows:

That, I am a Scheduled Tribe belonging to the Gangte Tribe, which is a recognized Tribe under the Constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989.

That, due to the prevailing ethnic crisis in and around Imphal, and during the absence of my family members who were in Kangpokpi district for a Family meet, I left our rented resident owned by *Jiten (6009115243)* located at Type II, Langol, Imphal West, *P.O. & .P.S.-Lamphelpat, District-Imphal West* on the 4th of May, 2023 at around 8:15 AM, I escaped to save myself and took refuge at different places and camps. And it has come to our knowledge that our deserted residence was attacked and looted by a Group of radical Meitei/ Meiteis suspected to be members of Arambai Tenggol and Meetei Leepun on the 12th of June, 2023 at around 3:30 PM.

That, the criminals broke open my door, destroyed and looted everything and the total evaluation of properties looted/ destroyed from my house/ premise is worth about Rs.32,50,500 /- (Rupees Thirty-Two Lakhs Fifty Thousand Five Hundred) only.
