
Dear Madam,

With reference to the above cited subject, I have the honour to report to you as follows:

That, I am a Scheduled Tribe belonging to the Gangte Tribe, which is a recognized Tribe under the Constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989.

That, due to the prevailing ethnic crisis in and around Imphal, I and my family left our rented resident owned by Nayan (9911272174) located at Changangei, Maning Leikai, Imphal West, P.S.-Lamphal, District-Imphal West on the 4th of May, 2023 at around 8:30 AM, with the help of the Airport Security we were escorted to Imphal, Tulihal Airport and took refuge for about 18(eighteen) days. And on the 22nd of May,2023 we head to Dimapur and from Dimapur we went to Guwahati on the 28th of June,2023. It has come to our knowledge that our deserted residence was attacked and looted by a Group of radical Meitei/ Meiteis suspected to be members of Arambai Tenggol and Meetei Leepun on the 4th of June,2023 at around 3:30 PM.

That, the criminals broke open my door, destroyed and looted everything and the total evaluation of properties looted/ destroyed from my house/ premise is worth about Rs.25,61,200/- (Rupees Twenty-Five Lakhs Sixty-One Thousand Two Hundred) only.
