Report on unlawful assembly, promoting enmity between different groups on ground of religion and race, uttering words etc with deliberate intent to wound the religious feelings of any person, Attempt to murder, Theft in dwelling house etc, Robbery, Dacoity, Mischief, House breaking/trespass, Criminal intimidation and unlawful displacement committed by the unruly goons of Meetei/Meitei Community.

Sir/Madam,

I, Smt. Lalmangaihzuai, aged about 55 Years, W/o Shri Lalramnghaka, a resident and occupants of CP Qrts. Type 2 No. 3, Lamphelpat, P.O. & P.S. Lamphel, Dist. Imphal West, Manipur, would like to placed the following few facts for your kind and sympathetic consideration;

1. That, I am a Schedule Tribe belonging to Mizo Community/Tribe which is one of the recognised tribes within the state of Manipur, India and i am serving as Attendant , Grade IV at Regional Institute of Medical Science, Imphal, Manipur.
2. That, I, along with my family members were forced to leave our resident Quarter allotted to me which is situated at the abovementioned address on the 4<sup>th</sup> May, 2023, at around 8:00 AM due to the ethnic conflict prevailing between two communities within the State of Manipur.
3. That, it may be mentioned here that we had to run for our life on the abovementioned date and time when the Law Enforcement Authority despite their presence in and around the locality failed to acted upon when some armed miscreants suspected to be the members of Arambai Tengol and Meitei Leepun belonging to the Meetei/Meitei community continue their manhunt upon the Zo ethnic tribals (Kuki-Zomi-Hmar-Mizo) by entering their locality and burning down their properties, killing, looting and launching an organised attacked since the evening of 3<sup>rd</sup> May,2023, in and around Imphal Valley Districts.

That, the condition and status of our resident quarter bearing CP Quarter Type 2 No. 3, situated at Lamphelpat, Imphal West, and the whereabouts of my/our household items including movable/immovable properties worth around **Rupees 5,00,000/- (Rupees Five Lakhs Only)** approximately are unknown till now as we are presently taking shelter at Rengkai Village, P.O. & P.S. Churachandpur, Dist. Churachandpur, Manipur, due to the prevailing circumstances.

In the light of the above facts and circumstances, I humbly request your good office with folded hands to kindly take strong actions by registering a ZERO FIR and process them to the competent Jurisdiction for initiating an investigation so that the culprit/perpetrator(s) can be book according to the law of the land.


