- 1. That, I am a Schedule Tribe belonging to PAITE Community/Tribe which is one of the recognised tribes within the state of Manipur, India and I used to served as Superintendent, MOF, Custom & GST, Govt. Of India, situated at North AOC, Imphal, Manipur.
- 2. That, I, along with my family members were forced to leave our resident, which is situated at the abovementioned address on the 4th May, 2023, at around 8:30 AM, due to the ethnic conflict prevailing between two communities within the State of Manipur.
- 3. That, it may be mention here that we had to run for our life on the abovementioned date and time when the Law Enforcement Authority despite their presence in and around the locality failed to acted upon when some armed miscreants suspected to be the members of Arambai Tengol and Meitei Leepun belonging to the Meetei/Meitei community continue their Treated as an of manhunt upon the Zo ethnic tribals (Kuki-Zomi-Hmar-Mizo) by entering their locality and of the Ease under burning down their properties; killing, looting and launching an organised attacked since the FIR No. 2430 (9)23 evening of 3<sup>rd</sup> May,2023, in and around Imphal Valley Districts.

That, the condition and status of our resident's situated at Lamphelpat, Imphal West, and the whereabouts of my/our household items including movable/immovable properties worth around Rupees 3,70,000/- (Rupees Three Lakhs Seventy Thousand Only) approximately are unknown till now as we are presently taking shelter at Lailam Veng, Central Lamka, P.O. & P.S. Churachandpur, Dist. Churachandpur, Manipur, due to the prevailing circumstances.

In the light of the above facts and circumstances, i humbly request your good office with folded hands to kindly take strong actions by registering a ZERO FIR and process it to the competent jurisdiction for initiating an investigation so that the culprit/perpetrator(s) can be booked according to the law of the land.
