I, G.Nengkhanpau age about 56 years S/O(L) G.Vuizadou a resident of Qrts No. 17, Type –III AIR Staff Colony, Lamphelpat P.O.& P.S. Lamphel, District Imphal West presently staying at Dorcas Veng New Lamka, Churachandpur would like to bring to your kind knowledge that I am Scheduled Tribe belonging to a Paite Tribe working as Technician in All Indian Radio,Imphal that due the ethnic violence in Manipur I along with my family fled for our safety leaving behind all our property toward Delhi after taking shelter at Lamphel CRPF Camp and that on the 16th June 2023 at around 1:00pm Meitei miscreant suspected to be member of Arambai Tengol and Meitei Leepun vandalized our house after looting all the property in it.

My loss incurred in this looting may amount to a value of Rs.7,000,000/-(Rupees Seventy Lakhs Only) including of 3-set of Computer used for editing, Camera, Electronic items, Furniture, Wardrobe, various household item etc. It may be mention that my scooty Suzuki Pleasure Reg. No. MN01 Z 0366, Engin No.IF16EBCGA36136 was also stolen during this rampant.

That, due to frequent shifting of places I am unable to file this report in time as such I humbly would like to request you to kindly allowed me in filing this report so that necessary action may be initiate at the earliest for the end of justice.
