Sir,


I have the honour to state that, on 04-05-2023 at around 3:10 pm some unknown miscreants suspected to be members of Meitei Youth Organisations, Meitei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 1000-2000 persons carrying sophisticated weapon like AK Rifles, SLR, INSAS and .303 Rifles, forcefully entered our locality, Khongsai Veng, Laipham Khunou, Imphal East, 795010 and they looted all the valuable and moveable properties and cash and burnt down all the remaining things into ashes leaving us homeless.

The list of properties destroyed or loss are mention in the **Annexure (enclosed)**. The Approximate value of destroyed or loss properties is calculated at about Rs. 60,06,500/- (Sixty lakhs si thousand and five hundred).


It is, therefore, requested you to kindly register a regular case and take necessary legal action against the culprits according to law.
