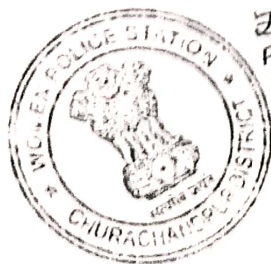
Sir/Madam,


