Sir,

I have the honour to state that, on 03-05-2023 at around 07:30 pm some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 1000 persons carrying deadly weapons and fire arms entered our locality. National Game village, Zone -I, B/346, Imphal West District, Manipur about 46 km South from Saikul PS. Fearing lost of live and to safeguard our life I alongwith my family left our Quarter house with all the household properties and fled to a nearby CRPF camp.

It is learnt that, some unknown miscreants vandalised my house and looted all the valueable and moveable household properties and it is also learnt that my quarter have been occupied by sc

unknown person without my consent.

The list of properties destroyed or loss are mention in the Annexure (enclosed). The Approximate value of destroyed or loss properties is calculated at about Rs. 13,69,000/- (Thirteen lakhs sixty nine thousand).

It is, therefore, requested you to kindly register a regular case and take necessary legal action against the culprits according to law.
