That, due to fear and intimidation by the majority Meitei's, our family left our home situated at, at Langgol Lamkhai, Imphal Municipal Council, Imphal West-795004, P.O. &P.S.-Lamphel, Manipur on 4th May 2023 at around 1:00 PM and took shelter at CRP Camp Lamphel, leaving behind all our household items and belongings including certificates, other important documents and all our valuable assets.
- 3. That, we came to know from local reliable source that our home has been vandalized and looted on 12<sup>th</sup> August, 2023 at around 8:00 AM.
