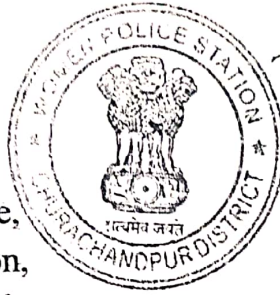

Sir/Madam,

With reference to the above cited subject, I have the honour to make this report to you for your kind and favorable and action please:

1. That, I belong to the Scheduled Tribe, HMAR Tribe, domiciled within Imphal West District, Manipur and now a Displaced person taking refuge in Rengkai, Churachandpur.
2. That, due to fear and intimidation by the majority Meitei's, our family left our home situated at, at **Langgol Lamkhai, Imphal Municipal Council, Imphal West-795004, P.O. & P.S.-Lamphel, Manipur** on 4th May 2023 at around 1:00 PM and took shelter at CRP Camp Lamphel, leaving behind all our household items and belongings including certificates, other important documents and all our valuable assets.
3. That, we came to know from local reliable source that our home has been vandalized and looted on 12th August, 2023 at around 8:00 AM.
