Subject: - Complaint/ Report on crimes of looting, vandalism and arson-attack of properties / discrimination of Scheduled Tribes.

Dear Madam,

With reference to the above cited subject, I have the honour to report to you as follows:

That, I am a Scheduled Tribe belonging to the Hmar Tribe, which is a recognized Tribe under the Constitution of India, by virtue of which I am being entitled to the protection under the SC/ST (Prevention of Atrocities) Act, 1989.

That, due to the prevailing ethnic crisis in and around Imphal, I and my family left our permanent resident located at Ebenezar Villa, Langol, P.O. & P.S.- Lamphelpat, District-Imphal West-795004, on the 6^{th} of May, 2023 at around 3:30 AM, where we made an escape to save our lives, took refuged at Central Reserve Police Force (CRPF) Camp, Lamphel, the very same evening with the help of the said CRPF Jawans we were escorted to Imphal Airport, took a flight to Mumbai, stayed for few days and again travelled to Bangalore, staying at relatives place. And, it has come to my knowledge that my properties from the deserted residence(3 storyed) was looted parts by parts, then the remaining items was vandalised and destroyed by a Group of radical Meitei/ Meiteis suspected to be members of Arambai Tengol and Meetei Leepun. And, after all those criminal activities took place, they finally started an arson-attack on the said building on the 4th, 5th & 7th of August,2023.

That, while they were carrying out their criminal activities. It seems to me that all these has taken place at the instance of the Manipur State Government as the perpetrators openly claimed and shouted that nobody would stop them, even the police because everyone, including top officials of the Manipur Government are patronizing them and that that no harm could be done to them.
