Subject:- Request to register a complaint (Zero FIR) in c/w recent attacked

Madam.

With reference to the above cited subject. I would like to report that on the 4th of May, 2023 around 8 AM, Meitei miscreants whom were suspected to be instigated by Arambai Tenggol and Meitei Leepun had attacked my residential house situated at Spring Villa, Phaipijang, Langol, PO & PS- Lamphel, District- Imphal West.

Due to such unprecedented attacked of ethnic cleansing of Kukis at Imphal, we being in state of vulnerability, fearing to lose our lives. I along with my family fled from our residential house and took refuge at the 143 Battalion, CRPF Camp at Lamphel near Exchange Office.

Upon Inquiry, I came to learn that my residential house was ransacked, vandalized and looted by the miscreants.

I therefore pray to your kind self to intervene and register a complaint (Zero- FIR) of cognizable offence carried out against me and my family for the ends of Justice.
