Sapur market, Imphal, Lamphelpat.

That, on the May 3, 2023 at _____ my above said residence "Owned/Rented" was attacked, destroyed, looted and burned by a Group of Meitei/Meiteis radicals.

These criminals broke/open my gate(s), destroyed and looted every valuable property from my residence and premises worth Rupees 1,60,400/- (Approx.) and they burnt down all the remainings.

While carrying out their said criminals activities; the said Meitei radical groups were shouting anti-tribal slogans..

I, therefore, request you to kindly take strong actions against the perpetrators by registering an FIR/Zero FIR under relevant sections of Law.
