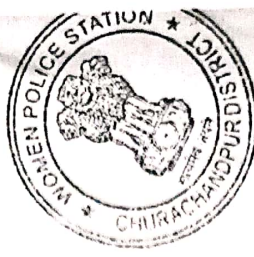

was attacked, destroyed, looted and burned by a Group of Meitei/Meiteis radicals.

These criminals broke/open my gate(s), destroyed and looted every valuable property from
my residence and premises worth Rupees 1540000 (Approx.) and they burnt down
all the remainings.

While carrying out their said criminals activities; the said Meitei radical groups were
shouting anti-tribal slogans..

I, therefore, request you to kindly take strong actions against the perpetrators by registering
an **FIR/Zero FIR** under relevant sections of Law.
