With reference to the above cited subject I have the honour to report to you as follows:

- 1. That I Limkhosei Baite aged about 63 years S/o (L) Jilthong Baite Belonging to the Vaiphei Tribe / Community, a schedule Tribe recognized under the constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989, and that I am a permanent resident of Langol Phaipijang (Spring Villa), PO/P S- Lamphel.
- 2. That at about 3 pm on the 16th June 2023, Some unknown person suspected to be members of the Arambai Tengol and Meetei Leepun attacked our locality and burnt down my house while me and my family members are taking shelter at Guwahati due to the ethnic violence in Manipur.
- 3. That, it may be reported here that the above said criminal activities have caused grave mental agony and (Rupees Fifty Lakhs) only incurred a huge loss which may be estimated to be Rs. 5000000
- 4. Fortunately, me and my family managed to escaped from the criminals who even tried to even kill us, and now currently taking refuge at Guwahati.
- 5. That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and settled at Guwahati. And ,thus I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register an FIR/ZERO FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
