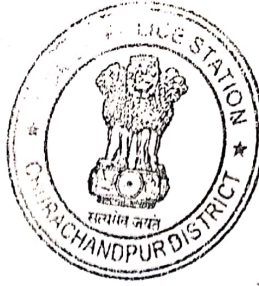

Subject :- Report on Looting, vandalism and burning down of house and household items/assets and Documents.

Madam/Sir

With reference to the above cited subject I have the honour to report to you as follows :

1. That I **Limkhosei Baite** aged about 63 years S/o (L) **Jilthong Baite** Belonging to the Vaiphei Tribe / Community, a schedule Tribe recognized under the constitution of India , by virtue of which I am being entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989**, and that I am a permanent resident of **Langol Phaipijang (Spring Villa), PO/P S- Lamphel**.
2. That at about **3 pm** on the **16th June 2023**, Some unknown person suspected to be members of the **Arambai Tengol and Meetei Leepun** attacked our locality and burnt down my house while me and my family members are taking shelter at **Guwahati** due to the ethnic violence in Manipur.
3. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred a huge loss which may be estimated to be **Rs. 5000000 (Rupees Fifty Lakhs) only**
4. Fortunately, me and my family managed to escaped from the criminals who even tried to even kill us, and now currently taking refuge at **Guwahati**.
5. That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and settled at **Guwahati**. And ,thus I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register an **FIR/ZERO FIR** , investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And , for which act of kindness, I shall always remain thankful to you and obliged.
