The total loss is estimated to be at an amount of around Rs.4,00,000/-(approx).</u>

Fortunately, me and my family members managed to escape from these criminals who even tried to kill or burnt us alive, and now currently taking refuge at <u>D. Phailen Village, Churachandpur, Manipur.</u>

Therefore, I, kindly request you to please take necessary action in this matter and come up with positive solution.
