Sir,

I, the undersigned would like to bring forth to your knowledge and report that I, am a resident of Type-1/1, CPWD Quarter, Sangaiprou, Imphal, PO & PS: Lamphel, Imphal West, Manipur and that some armed radicals belonging to the Meitei/Meitei community broke open my resident and vandalized, looted and gutted/burnt down my properties (academic documents/service documents/books, etc) within the quarter. The total loss is estimated to be at an amount of around Rs.4,00,000/-(approx).

Fortunately, me and my family members managed to escape from these criminals who even tried to kill or burnt us alive, and now currently taking refuge at D. Phailen Village, Churachandpur, Manipur.

Therefore, I, kindly request you to please take necessary action in this matter and come up with positive solution.
