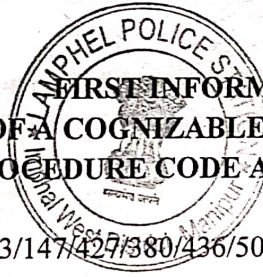

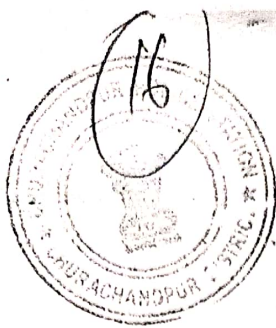

was attacked by a Group of Meeitei/Meitei's goons numbering 500 to 1,000 men.


These criminals broke open my gate(s) and looted every valuable property from my
