I, the undersigned would like to bring forth to your knowledge and report that I, am a permanent resident and native of Gymbaiding, Room No. 9, of Angeli Housing Complex Village, P.O. & P.S. Lamphel District Imphal West Manipur and that some armed radicals belonging to the Meetei/Meitei community broke open my rented/residential home and vandalized, looted and gutted/burnt down and all what is within and along with the house was lost to the said meetei/meitei armed radical groups illegal activities a total loss estimated to be at an amount of Rs. 64,600.00 Only. ON 07/6/2023 at around 2:00 pm

Fortunately, me and my family managed to escaped from these criminals who even tried to kill or burn us alive, and now currently taking refuge at, Mualveng, Hiangtam Lamka.

Therefore I kindly request you to please take action in this matter and come up with positive solution.
