

Subject:- Report.

Sir,

With due respect, I have the honour to state that today, (i.e 13.09.2023) at about 10.00 AM, I have received an information that on 12<sup>th</sup> September, 2023, (the timing of the incident could not be ascertained), my household articles including movable and valuable gold ornament and cash which were left behind at my house constructed at a plot land jointly owned with my younger brother, Konsam Vinova under Patta No.40(old)/3098(new) located at Moreh Bazar Ward No.6, was learnt to have been looted/stolen by the unknown miscreants suspected to be KUKI mob. The caretaker of my house had previously evacuated from the Moreh Town due to the ongoing communal clashes erupted since 3<sup>rd</sup> May, 2023 and now, my caretaker and his family is presently living at the relief camp at Akampat, Imphal-East District. The approximate value of the household articles including movable and valuable gold ornament and cash which were looted/stolen by the suspected Kuki mob is about Rs 20,00,000/- (Rupees twenty Lakhs).

So, I therefore kindly request you to take up necessary legal action against the unknown miscreant as per law.
