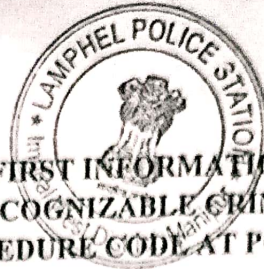

Subject: Filing of F.I.R on loss and destruction of property

Sir,

In reference to the subject cited above, I would like to report that, due to the unrest in Manipur which started on the 3rd of May 2023, a group of miscreants belonging to Meitei community in huge number looted and vandalized my properties (copy enclosed) located at Langol Phaipijaang, Joseph Colony opposite Lainingthou near Singlul Turf ground under Imphal West District bearing Patta no.168(old), 2308/3467(new), Dag no. 2634/2669, Area(in Ha)0.0302, class of Land – Homestead.

The approximate value of destroyed/looted properties is estimated to be around ₹ 79,40,000/- (Rupees Seventy nine lakhs forty thousand) only approximately. I, therefore request you to take up necessary action as per the law of the land.
