Subject:- Registration for FIR. of burning of my residentiaphal West District, Manipur located at National Game Wilage, just below zone-I, L/W, Near KBC Church.

Sir,

With due respect, I have the honor to state that the following few lines before you for your kind consideration and sympathetic order.

Since 3rd May, 2023 violence started in the state of Manipur. At around 9:30pm burning of houses started in our areas. We left the house to save our lives. At the same evening at around 11:15pm we reached 36 Bn CRPF Camp, Lamphelpat near DC Imphal West Office and took shelter there till the time we able to leave Imphal. After one and half month we are able to leave Imphal and reached Delhi safely. Now we stayed at my husband posting place at Delhi. I alone came back to Churachandpur for lodging an FIR. The house is burned down and all my belongings are looted and burned down by Meitei Mobs, along with Meira Paibi, Arambai Tengol and Meitei Leepun. on 04/05/2023 at around 11:00 pm.

I, Therefore, request you to kindly taken up necessary action against those culprit involved in the arsonies.
