



That, today i.e. on 16/9/2023 at about 10.30 am, my brother namely Serto. Thangthang Kom, aged about 41 yrs S/o Late. S. Aphum Kom of Litan, Kakching Chandel A/P Tarung Neikalong, Thangmeiband who is an Ex-Army and presently serving as a Defence Security CORPS at Leimakhong has been kidnapped or abducted from his residence gate by 3 (three) unknown arm miscreants coming on a white car and fled to an unknown direction.
