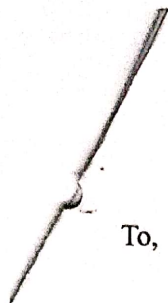

That, on the **2<sup>nd</sup> of May, 2023** at around **1:15 PM**, I left for Dongjang Village, near Sugnu, to deliver my Mother's Medicine which was mostly available at Imphal and due to the ethnic crisis, I couldn't return back to Imphal to continue with my Research. I would also like to add that I have deserted my Two-Wheeler (Automatic Scooter), make and model is Bajaj Vespa VXL 150, 2W Yellow in Colour, bearing Regn. No. MN 01 AH 8334, registered under the name, Thongkhogin Baite which estimated to be Rs. 1,40,000/- (Rupees One Lakh Forty Thousand) Only.


