With reference to the above cited subject, I have the honour to report to you as follows:

That, I am a Scheduled Tribe belonging to the Hmar Tribe, which is a recognized Tribe under the Constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989.

That, due to the prevailing ethnic crisis in and around Imphal, I along with my family left our permanent resident located at Opp. Shija Academy of Health Sciences Junction, near Laimanai Auto stand, Lanthungching, District-Imphal West on the 14th of May, 2023 at around 12.00 PM we were escorted to Tulihal International Airport, Imphal by the Central Force. And, it has come to our knowledge that our deserted house was attacked, destroyed and looted by a Group of radical Meeitei/Meiteis suspected to be members of Arambai Tengol and Meetei Leepun on the 30th of July, 2023 at around 1:30 PM.

The criminals broke open my door, destroyed and looted every valuable property from my house/ premise's worth about Rs.13,22,700/- (Rupees Thirteen Lakhs Twenty-Two Thousand Seven Hundred) only.

In the given circumstances, I humbly pray you to kindly register a ZERO FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
