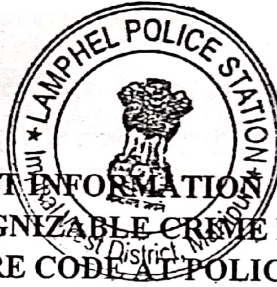

The situation has become more and tense and it was not safety to stay in Imphal area. So, we left our residential house at on 4th May, 2023. On 20th July 2023 our residential house at Joseph colony, Phaippijang, Langol was vandalized and looted all my household properties by Meitei miscreants.
