Subject: - Complaint/ Report on the crimes of vandalism and arson attack on a vehicle and on discrimination of Scheduled Tribes.

Dear Sir/Madam,

With reference to the above cited subject, I have the honour to report to you as follows:

1. That, I am a Scheduled Tribe belonging to the Vaiphei Tribe, which is a recognized Tribe under the Constitution of India. And, I am a permanent resident of Lhingsiphai Village, P.O., P.S. & District- Churachandpur, Manipur.
2. That, on the 3rd of May, 2023, at about 6:30PM, a huge contingent of armed radical Meitei/ Meeteis suspected to be members of the Arambai Tenggol and Meitei Leepun attacked Khongsai Veng, P.O. & P.S.-~~Lamphel~~, Imphal West District, Manipur and in the process, they have vandalized and torched my vehicle, Jeep Compass (4x4) which was parked at the roadside in Khongsai Veng.
3. That, it may be reported here that the miscreants were shouting slogans like- "KANGLEIPAK YAIPHARE"; "KUKI HATLO"; "HAO HATLO"; etc. while they were carrying out their criminal activities. It seems to me that all these has taken place at the instance of the Manipur State Government as the perpetrators openly claimed and shouted that nobody would stop them, even the police because everyone, including top officials of the Manipur Government are patronizing them and that that no harm could be done to them.
4. That, at the time of the attack, my friend, Mr. Thangkhanlal and his wife, who were using my said vehicle, somehow managed to escape to save their lives under the compelling circumstances with some injuries while my only coveted vehicle was totally burned. It may be mentioned here that the registration process of my said vehicle was applied for and 5th May, 2023 was fixed for installing High Security Number Plate at the DTO/ Imphal East, Manipur.

5. That, the total loss suffered by me could be estimated to be about Rs. 28,00,000/- (Rupees Twenty Lakhs) only.
 6. That, I am filing this information lately because I was at different places due to the ongoing ethnic crisis which crippled the whole state of Manipur.

In the given circumstances, I humbly pray you to kindly register an FIR/ ZERO FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
