That, due to the ongoing conflict between kuki and meitei, I am compelled to leave the above mention quarter at National Games Village on the 4th May, 2023.

That, on the 19th May, 2023 at around 7:00 Am. I received an information from a reliable source that my belongings which I have left behind were all looted and plundered by unknown miscreants. The approximate value of properties looted were estimated to be about Rs. 13,40,200/- (Thirteen Lakh Forty Thousand Two Hundred Only)

So, I therefore request your good office to kindly take up necessary legal action in this regard.
