My name is Henminthang Haokip, aged about 48 yrs, S/o (L) Dongson Haokip and I am a native of Spring Villa, Phaipijaang, Langol, Imphal West, Manipur under Lamphel Police station, Imphal -West, & 795004, Manipur . I am currently residing in Saitu Gamphazol, Kangpokpi district.

I have the honour to report that on 5th August, 2023 around 7.00 A.M, Meitei radical groups namely Meetei Leepun and Arambai Tenggol started attacking our locality, first they vandalized and looted the houses of all the furnitures, household items and valuables and finally torched down the whole locality including my house.

I am filing this FIR here in Saparmaina police station as I could not file an FIR at my local Police station since we are driven out of our home in Imphal on 3rd May 2023 and currently residing in S. Lhangnom village, Saitu Gamphazol, Kangpokpi District.

The value of properties destroyed is around 1 crore (Approx.) and market value of the house /plot is around 1 crore. (Approx.).

Now I am left with nothing as me and my family had to run for our lives and had a narrow escape from death on the 3rd of May 2023, when all this communal attack started. This horrible incident has had a profound impact on our lives and we feel violated and unsafe in our own homes and I hold the authorities responsible for not providing adequate security measures to prevent such gruesome attacks from occurring.

Therefore, I request you to allow me to file Zero FIR as I could not file a complaint at my

home town. Thank you for your attention to this matter.
