I have the honor to state that on 05/08/2023 at around 0730 PM some unknown miscreant suspected to be a members of Meitei Youth Organization, Meitei Leipun, Arambai Tengol numbering about 1000 persons carrying sophisticated weapons-like AK-47, INSAS & SLR forcefully entered our locality 91 Meitei Langol, Imphal West, Manipur, Pin- 795004 and burnt down my house built on my Dak No.- 779/1259 (A) (Ingkhol) and destroyed all the building material that I have kept.

The approximate value of the lost property is calculated at about Rs. 1.5 crores.

It is, therefore, requested you to kindly registered a regular case and take necessary legal actions against the culprits accordingly to law.
