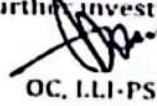

I, the undersigned would like to raise a complaint against a group of miscreants. That on 3rd May 2023 at around 7: 30 AM, where a group of miscreants numbering more than 3000 attacked my residence at N.Heikon village, Kangpokpi District, Manipur along with my family members. Fortunately we had a narrow escape and run for our lives, but the group of miscreants looted all our properties and burnt my house. The miscreant destroyed my Aactiva 6G bearing no. – MN01AN0650.

The value of loss/damaged properties is estimated to be around Rs 10 Lakhs approx.

I therefore request you to kindly register an FIR against the miscreants and take necessary legal actions at the earliest.
