As per endorsement vide GD Entry NO. 19/SMG-PS/2023 dated 17/08/2023 regarding receipt of information of obstruction to the personnel of 2/8 GR while they were performing lawful duty at Taretkhul, I have conducted an enquiry in this regard. In that, it has been ascertained that on 17/08/2023 at about 7:30 pm a mob of some unknown Meira Paibi and some unknown persons of Taretkhul caused obstruction to the personnel of 2/8 GR when they tried to apprehend two youths holding fire arm who came in one Grey Hyundai i 20 car bearing registration no. WB- 38 X5656. The obstruction/ resistance of the mob made release of the apprehended youths along with the car from the custody of 2/8 GR personnel.

It is therefore requested to take necessary action against the accused persons.
