2. Shri Hanjabam Satananda Sharma alias Sanatomba Sharma, aged about 52 years, S/O late H. Nandakishore Sharma, a resident of Wangkhie Ningthem Pukhri Mapal, P.O. & P.S. Porompat, Imphal East District, Manipur.
3. Shri Hanjabam Bhaktaraj Sharma, aged about 17 years, S/O H. Memory Sharma, a resident of Wangkhie Ningthem Pukhri Mapal, P.O. & P.S. Porompat, Imphal East District, Manipur.
4. Shri Hanjabam Barin Sharma, aged about 51 years, S/O late H. Gosai Sharma, a resident of Wangkhie Ningthem Pukhri Mapal, P.O. & P.S. Porompat, Imphal East District, Manipur.

Madam,

I am writing to bring a serious matter to your attention that occurred on 23rd November 2023 at around 5.40 p.m. The details of the incident that happened on 23rd November 2023 are as follows:-

proposed operation, which would take several weeks. Further, I was prevented from performing my activities being a Vice President of the Universal Mother Association, Thoubal Branch as a result of my injury. (I am attaching all supporting medical documents for your kind perusal)

5. That the Accused Persons insulted me using flirty language, disrobed my chador intending to outrange my modesty apart from beating and thrashing as stated above thereby causing a fracture of the nasal bone. This incident has caused me a great deal of distress and anxiety, and as I was bedridden for a long time I could not submit the present complaint just after the incident. However, just after recovering from my illness, I am submitting the present complaint to your good self to do the needful. I am willing to cooperate fully in any investigation that may follow and provide any further information as required. The Accused Persons had committed criminal assault that caused grievous hurt and also caused insulting and outraging of my modesty.

It is, therefore, prayed that an FIR may kindly be registered and the Accused Persons be arrested and brought to the books and tried in accordance with the procedure established by law in the interest of justice.

1. That on 22nd November 2023, I received a phone call from my younger sister, Hidam Ongbi Hanjabam Ningol Mala Devi informing me that our mother Sudheina Devi (81 years) was confined to bed and as such I have been asked to come tomorrow to look after our mother. Consequently, on the next day i.e. 23rd November 2023 in the morning at around 7 a.m., I came to my maternal house to look after my ailing mother. After reaching my parental home, I came to know that on 22nd November 2023, there was an incident of verbal confrontation between our mother on one side and Hanjabam Bombo alias Milan Sharma and Hanjabam Ongbi Mema Devi on the other wherein they levelled unfounded charges by saying that our mother had erroneously shifted the demarcation peg, which was erected by the Official of Settlement Department in the past after completion of a demarcation proceeding. However, the said allegation was denied by our mother. Since our mother was an old woman having different ailments, the allegations made by above named individuals had drastically impacted her health condition and as such she was confined to bed.

2. That on 23rd November 2023, my younger sister engaged a Muslim Mistry to erect iron posts for installing a gate along the approach lane. At around 5.40 p.m. while I was near the approach lane behind the house of Aribam Birahari Sharma and in front of Mema's house along with my two sisters namely Hidam Ongbi Hanjabam Ningol Mala Devi and Kongbrailatpam Ongbi Hanjabam Ningol Nirmala Devi, the above named Accused Person No. 4 rushed in all of a sudden and started attacking me and my sisters. Soon after the said attack, the remaining Accused Persons rushed in and they also started attacking me and my sisters. Firstly the Accused Person No. 4 punched my face severely. As a result, I fell on the ground and while I was falling on the ground, the Accused Persons trampled upon me, rained severe blows, kicked and
