Subject: Complaint against (1.) Mr. Bonny Haobam, S/o late Haobam Inaocha, residing at Khurai Ahongei, Irabot Leirak, Manipur - 795005 (2.) "Huiyen Mamom", an organized women's group operating out of Manipur.

I, Bimola Takhelmayum, D/o late Takhelmayum Biramani, residing at Khurai Thoidingjam Leikai, Porompat, Manipur- 795005, am filing this criminal complaint being a guardian (paternal aunty to the victim) against Mr. Bonny Haobam residing at Khurai Ahongei, Irabot Leirak, Manipur - 795005 and "Huiyen Mamom", an organized women's group operating out of Manipur.

In this regard I would like to state as follows:

- 1. On the evening of 04.01.2024 at around 10:45 PM, my niece, Jessia Takhelmayum was having a conversation with her friend's relative brother Mr. Bonny Haobam, through text message. The conversation between Mr. Bonny and her started off in a friendly and cordial manner and continued that way until suddenly, Mr. Bonny began using derogatory language and demeaning terms against her and accused her of being a blind follower of Khurai Constituency MLA, Sushindro. As a sudden and provoked reaction, my niece unintentionally referred to the women's group "Huiyen Mamom" as "LawaiNupi" which literally translates to "Village Women". This statement was made completely unintentionally during a private conversation and only as a reaction to the derogatory statements made by Mr. Bonny Haobam.
- 2. However, it was shocked and surprised that Mr. Bonny Haobam completely disregarded her privacy and shared screenshots of the conversation with him to the women's group "Hulyen Mamom" which is known throughout Manipur for moral policing and irrational and unlawful physical assault of women.

done purely out of malice and ethnic rivalry and hatred of which shehave become an accidental victim.

- 8. The actions that were taken against her by the members of "Huiyen Mamorn" were completely illegal and unlawful and amount to criminal force, assault, voluntarily causing of hurt, criminal intimidation, wrongful confinement, defamation and other offences under the Indian Penal Code, 1860 because she was forcefully taken to Khurai Puthiba Laishang, physically slapped and forced to make an apology under threat of assault. Moreover, the very act of sharing screenshots of a private conversation to a third party by Mr. Bonny without her consent amounts to a violation of her privacy, and none of the events that took place thereafter would have ever occurred if Mr. Bonny had not shared screenshots of the conversation with him, thereby invading and violating her privacy.
- 9. In light of these facts, I sincerely request you to take my complaint on record and register an FIR in respect of the offences committed by Mr. Bonny Haobam and the Women's Group "Huiyen Mamom" under Sections 319, 321 and 323 (causing of hurt),340 (wrongful confinement), 350 (criminal force), 351 (assault), 355 (assault or criminal force with intent to dishonour a person),503 (criminal intimidation), 499 (defamation), 34 (Common intention) of the Indian Penal Code, 1860 and 66 E of IT Act etc. and any other sections or offences that you may deem fit. - 10. That, there is few days delay on approaching the good-office in this regard but the same was due to the lack of legal intricacies/knowledge and due to persisting mental trauma to my niece. And in case of taking any statement of my niece would the goodself be convenient to visit at the residence of my niece.

- 3. On 05.01.2024, certain members of the women's group "Huiyen Mamom" arrived at my house when my niece was not at home and they began asking about her whereabout. When they were able to find out where she was, the group of women picked her up against her will and forced her to go with them to Khurai Puthiba Laishang which is a temple shed near my place of residence.
- 4. As soon as they took her to Khurai Puthiba Laishang, they didn't allow me to accompany with my niece andthey began to take a video recording of her and after which they physically assaulted her by slapping . Despite my niece cries of pain, they did not stop slapping her and they continued to take a video recording of all this. Eventually they stopped physically assaulting her and they asked her to make an oral apology for calling and referring to them as "Lawai Nupi". She agreed to their demands and apologized for her actions, and they took a video of this as well.
- 5. It was only after they had finished physically hurting and assaulting her, and they had recorded her apology that they released her and allowed her to return to me. She was extremely humiliated by what was done to her by members of "Huiyen Mamom" but I thought that the entire event was over and that she would not have to face such humiliation and unwarranted terror again.
- 6. However, later in the evening on 05.01.2024, the video that was taken of her being physically assaulted by members of "Huiyen Mamom" was being circulated to all the residents of Manipur and was being posted and shared on social media platforms such as WhatsApp and Facebook. In these videos her face was blurred and not visible but the rest of her body and attire were visible and she was easily identifiable by those who knew her and soon everyone became aware that the girl in the video was my niece. This caused her immense mental and emotional trauma and harassment, and she was completely humiliated once again.
- 7. The video continued to be circulated among people through social media platforms and on 09.01.2024, the original video showing her face and completely revealing her identity was posted on social media from the account of a person belonging to the Kuki Tribe while she is a person belonging to the Meitel community. The posting of the original video was
