I would like to report that on 04/05/2023 starting from 8:30 am onwards and unruly mob numbering to about 800/1000 assembled at Chassad Avenue, Porompat, Imphal East with an intention to cause harm and destroyed daos. The assembly mob turn violent and started vandalizing ransacking and burning houses in which a good number of residential houses belonging to Tribal Community were burnt down to ashes. We are also a victim of such mob violence in which my residential house and my vehicle was also completely burnt down by unknown miscreants on the same day.
