Subj: F.I.R. Regarding burning of ~~our~~ house by unknown persons during mob violence in Imphal on 04/05/2023.

During the recent violence in Imphal my residence "House no. 15 Haokip veng, mahabali Road, P.S. - Porompat, Imphal East man 795008" was vandalized and set on fire by some unknown persons on 4th May 2023 at around 1 p.m. (afternoon) along with the following items inside the house.

1. All furnitures, (Sofa sets, chairs, Tables, beds, Almirahs etc)
2. All Garments, (matresses, blankets, bed sheets, curtains, shoes & etc)
3. Electronic items like (TVs, Fridge, computer/Laptop, heater, P.V.C)
4. Kitchen utensils, (Oven, Gas stove, Gas cylinder, etc)
5. All Documents, (House Patta, Educational documents & certificates)
6. Four wheeler car parked in Garage Registration no: 4301AU2128

As the situation is still not normal it is not safe for me to live, I am presently taking shelter in Saparmeina at my relative's house.

Hence, I request you to kindly register my complaint as per F.I.R. "C/o, Seikhopao Haokip, Saitu Saparmeina Village, Kangpokpi District, Manipur 795132 for necessary action please.
