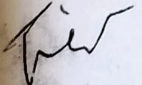

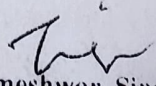

Sir, I have the honour to state that, on 4/05/2023 at 12 noon some unknown miscreant belonging to Meitei Youth of Irambai Jengol, World Meitei Council (WMC) Meitei Lempu and Kangleipak Kanba Lempu (KKL) numbering about 800-1000 members carrying sophisticated weapon like AK Rifles, SLR and 303 Rifles forcefully entered in my house, Haskip Veng, Imphal - East Porompat - Imphal, after looting all the valuable household properties, has been burnt down to ashes leaving us estimated about 5-6 Crores.

It is, therefore, requested to booked the culprits and take necessary legal action according to law
