

Subject: FIR regarding burning and looting of my house by unknown miscreants during mob violence in Imphal on 04-05-2023.

Dated : 16-05-2023



Sir,

During the recent violence in Imphal, my residence, Haokip Veng, Mahabali Road, PS Porompat, Imphal East, Manipur, 795005 was vandalised and set on fire by unknown miscreants on 4<sup>th</sup> May, 2023 at around 2 PM ( noon) , I am submitting the following items that were set on fire and looted inside my house for your necessary action:

1. All furniture's- 6 sets Leather-foam Sofa sets, 3 set Steel Chairs, Central Glass-top Tables, Imported Beds, Imported Admirals, Glass top Dinning table, 6 Dinning chairs, 3 Wardrobes, 4 Godrej Steel Admirals, 3 sets Dressing tables, 3 Diwan type beds , etc.) - Rs.6,00,000.00
2. All garments, mattresses, cushions, sewing machine, blankets, bed sheets, curtains, shoes, clothing's ( ladies and gents dresses), towels, etc.- Rs.5,00,000.00
3. Electronic items such as TV.(LCD), HP Printer, Computer Set, Washing Machine, Refrigerator, Room heaters, hair dryer, hair straightener, iron, electornic grinders, Oven, toasters, Air fryer, etc.Rs.5,00,000.00
4. Kitchen Utensils, Crockerries, OTG oven, Gas stoves,, large gas burner, 5 gas cylinders), water filter, electronic water heater, Geysers, Hot-cases, Pressure cookers,- Rs.4,00,000.00
5. 3 nos.Traditional Gongs, one Double barrel gun, 7 traditional neckles,Jewelleries, etc. - Rs.2,50,000.00
6. 4 sets of Laminated Board Fix wall Almirah/ Wooden Boxes, Bookshelf etc. - Rs.2,50,000.00
7. Hostel building items on 2<sup>nd</sup> floor -14 sets of wooden beds, 14 study tables, 14 chairs, Curtains, Partition board, doors, windows, 4 sets of wash basins, wall mirrors, room partition tin sheets, C.I. sheet roofing, ceiling fans, wall fans,electric fittings - Rs.12,00,000.00
8. Educational certificates, Awards including official documents, All personal service files, Pension papers, Bank Pass Books, Pan Cards, Driving Licence. Aadhaar Cards, Land ownership documents such as Pattas/Jamabandisreference books, etc Rs.1,50,000.00.
9. 4 nos. water Syntax tanks on top-floor ( 8,000 ltrs), 6 Jumbo Boxes, 15 Buckets - Rs.1,00,000.
10. Total value of goods, valuables and household items looted or destroyed is Rs.34,50,000.00
11. My house Ground plus 3 floor building with 15 rooms plus dinning and kitchen - Rs.10 crores.

My affected house is under the jurisdiction of Porompat PS, Imphal East, Pin-795005, as the situation is unsafe, I am presently taking refuge in my house in Saitu village.

Hence, I request you to kindly register my complaint as Zero F.I.R.
