

Sir,

I have the honour to state that today, i.e., 27/12/2023 at around 6:15 am while I was driving towards Bashikhong on my Swift Car White in colour bearing regd no. nil. On the way at Yubraj Palli near Pukhri Achouba some unknown youths numbering about 7/8 persons stopped me without any specific reason. Among them one of the youth pointed me with a small gun and directed me to come out of the Vehicle. Due to fear I follow as I was told to do so. Thereafter, they snatch the key of the vehicle and mobile phone. Two of them then forcibly drive my vehicle along the route towards Okram Chuthek, which was follow by their associates in a White Colour Bolero. All the relevant document of the vehicles was also inside my Swift Car. My Realme phone which they had looted bears a phone no. 6009724517.

It is therefore requested to take up necessary action against the unknown culprits and punished them accordingly, and also helps in recovering my vehicle and phone at the earliest.
