



Sir,

I have the honour to report that I along with my family members had been staying peacefully at a rented house owned by Village Chief namely Kamboi at Pashong Meitei Leikai, Litan PS, Ukhrul District over the last 50 years. However, on 3th May 2023 at about 7:00 pm some well equipped youth suspected to be Kuki militants started vandalizing and burning Meitei properties at Pashong, Meitei Leikai. Fearing of being killed by them, we escaped from the place and took shelter at Chingsang High school, Sanakeithel. Thereafter, we were transported to Yaingangpokpi Bazar by the Assam Rifles through their vehicle. We have left behind all the following properties at the rented house at Pashong Meitei Leikai:-
