

Subject: Report.

Sir,

I have the honour to state that today i.e. on 05/01/2024, at @ 12.30 pm a column of 39 Assam Rifle under my command laid down a routine frisking and checking post at Balijuri, Kashimpur, Jiribam area near Balijuri community hall and carried out checking of person randomly loitering in and around the area. While doing so, one unknown person approaching towards the frisking and checking point from Kashimpur side heading towards Mongbung Village holding one hanging bag (orange & yellow in colour). On seeing our party, the said unknown individual try to flee from the frisking and checking team in a very suspicious manner. Immediately, our party chased and overpower the said unknown individual and detained for verification at @ 1.10 pm of the day.

On questioning, the unknown individual identified himself as one Jabar Uddin (29) S/O Romij Uddin of Balijuri, Kashimpur, P.O, P.S & Dist. Jiribam, Manipur. Because of his suspicious manner, I have checked the article inside his hanging bag (orange & yellow in colour) and found one packet wrapped with transparent cello tape. Being suspicious, I have approached to one civilian available near the frisking and checking point and requested for witnessing while observing the formalities. The civilian identified himself as Nijam Uddin (32) S/O Rauz Uddin of Balijuri, Kashimpur, P.O, P.S & Dist. Jiribam, Manipur. Thereafter, I have unwrapped the said packet and found inside again wrapped with yellow colour plastic and again wrapped with brown colour paper. On further opening found inside blue colour pouch tied with rubber band containing inside orange colour numbers of small tablets, some of it were found marked as "R" and the remaining as "WY" which are highly suspected to be contraband drugs. On questioning, Jabar Uddin has stated that the drugs which he was carrying are contraband drugs. Subsequently, the said packet is again wrapped with transparent cello tape and weighed by using electronic weighing machine and found altogether weighing 1.138 Kgs (including plastic wraps). The said packet is marked as "P" in presence of independent witness.

Thereafter, the said packet marked as "P" along with the hanging bag (orange & yellow in colour) were wrapped with plain white cloth and packed & sealed by using wax with a five rupee coin and marked as "P-1". On that packed and sealed packet wrapped with plain white cloth marked as "P-1", I along with the witnesses as well as the accused person have put our respective signatures. Accordingly, the packed and sealed packet marked as "P-1" (containing contraband drugs marked as "P" and hanging bag) along with one Mobile handset (OPPO) were seized from the possession of the accused person by preparing a formal seizure memo at 2.00 pm. Then, I along with the witnesses and the accused person had appended our respective signatures on that seizure memo. So, the accused person was arrested at 2.10 pm of the day (05/01/2024).

It is, therefore, the arrested accused person and the seized articles are hereby handed over to you for taking further necessary legal action against him.
