MN02D0352 the vehicle roll down in backward position and fell down in the Gorge at 05:20 PM. One seriously injured person namely Md. Abdul Gaffar s/o Md. Sirajuddin was immediately evacuated to nearest Hospital at Paomata PHC, however he was declare dead. Whereas the other occupants who sustained bodily injuries were evacuated to Mao PHC with the help of localities and police personnel for further medical emergencies.
