



Today i.e., 22/02/2023, a combined team of 108 officers and men including Executive Magistrate SDC, Senapati, Senapati District Police, B/109 CRPF, Senapati, 4<sup>th</sup> IRB Taphou, Senapati led by ADDL.SP(NH-2)-SPT, AC B/109 CRPF and OC/SPT-PS under the supervision of SP - Senapati and DC - Senapati conducted an intensive Poppy/cannabis plants destruction drive at Sadim Hills ranges. In that, around 9-10 acres of opium poppy plants were destroyed. However, no cultivators were visible during the destruction drive.

A regular FIR Case No. 6(2)2024 SPT-PS u/s 18(b)/46 ND& PS Act has been registered for further legal actions.
