Sir,

With due respect, I have the honour to report that, I am running one excavator L& T case which was started working at Koubru Leikha, near Monlom stone crusher, Imphal river from 01/05/2023. On 03/05/2023 after completed the work I was parked my excavator L& T case at the said area and I had returned at my home. Due to the current ethnic violence in the state i.e. starting from 3<sup>rd</sup> May, 2023, I couldn't visit at the working place i.e. Imphal river near Kourbru Leikha. However, on 14/05/2023, it comes to light that in between 03/05/2023 and 10/05/2023 my excavator L& T case bearing Registration No. Nil having Engine No. 4H.3310/110061 and Chassis No. R11K02282 was stolen away by suspected to be kuki rioters and kuki militants which I was parked at the said area and couldn't traceable till date. The approximate value of the Stolen excavator L& T case is about Rs.8,50,000/- (Rupees Eight Lakh and fifty Thousand) only.

Regarding the matter I couldn't report timely to the concern police station i.e. Gamnom Sapormeina PS due to the lack of legal knowledge and present situation in the state. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
