Dear Sir,

It is to report that (i) Shri Thingbaijam Minaketan Singh, S/o Shri (L) Th. Ibobi Singh, a resident of Khurai Sajor Leikai, Imphal East District, Manipur, serving as Deputy Manager, while working as Manager-in-charge at the Kangpokpi Branch of the Manipur State Cooperative Bank Ltd. and (ii) Shri Mutum Arunkumar Singh, S/o Shri (L) M. Khogendra Singh, a resident of Hiyangthang Maning Makha Leikai, Imphal West District, serving as Senior Account Assistant, while working as Ledger Keeper at the Kangpokpi Branch of the Manipur State Cooperative Bank Ltd., who have been put under suspension by the Bank vide Office Order No. MSCB/76/2021-22/5195-5196 dated 21/01/2022 (Annexure-I & Annexure-II), has caused a loss of Bank's money amounting to Rs.1,36.50,000/- (Rupees one crore thirty-six lakhs fifty thousand) only in connivance with one MR. MONGBIJAM JOTIN SINGH, S/O SHRI M. IBOTOMBI SINGH of MONGSHANGEI MANING LEIKAI, Imphal West District, Manipur by way of sanction/advance of loans aggregating to Rs.1,36,50,000/-(Rupees one crore thirty-six lakhs fifty thousand) only between the period from 29/11/2021 to 29/12/2022 against the security of Bogus National Savings Certificates, as detailed in the annexed APPENDIX, issued by Sub Post Office- Tengra Colony, 24 PGS (N), Pin-743251, West Bengal to MR. MONGBIJAM JOTIN SINGH.

This report could not be submitted earlier due to the conduct of an internal inquiry vide Office Memorandum No. MSCB/76/2021-22/5161 dated 17/01/2022 (Annexure-III) as to the genuineness of the NSCs/Current Value of the NSCs/Lien marking letters etc. issued by the concerned Sub Post Office and waiting for the official confirmation letter from the Sub-Post Master, Tengra Colony, 24 PGS (N), Pin-743251, West Bengal/Superintendent of Post, Imphal Head Office, Imphal as sought by the Bank vide its letter No. MSCB/189/2021-22/5192 dated 20/01/2022 (Annexure-IV).

Further, it is to inform you that the Superintendent of Post, Imphal Head Office, Imphal vide his letter No. SB/Verification/Fraud/Corr dated 28/01/2022 (<u>Annexure-V</u>) has categorically stated that the NSCs pledged with the Kangpokpi Branch of the MSCB Ltd. are not genuine.

In view of the above facts and circumstances, It is prayed to kindly take up necessary legal action for recovery of the sum of Rs.1,36,50,000/- (Rupees one crore thirty-six lakhs fifty thousand) only fraudulently misappropriated by (i) Shri Thingbaijam Minaketan Singh, Deputy Manager (working as Manager-in-charge); (ii) Shri Mutum Arunkumar Singh, Senior Account Assistant, Kangpokpi Branch, MSCB Ltd.; and (iii) Shri Mongbijam Jotin Singh, S/o Shri M. Ibotombi Singh of Mongshanggei Maning Leikai, Imphal West District as also to book the culprits under the law,
