Today i.e the 10th August, 2023 at 3:20 pm received reliable information that on the same day at about 3: 00 pm one empty vehicle Tata (mini) B/R.No. MN01-AA-4067 moving towards Imphal collided with one Shaktiman B/R.No. MN-01-9562 coming in opposite direction in between Daili village and Yaikongpao village on NH-2. As a result of the mishap, the driver of the aforesaid Mini-Tata succumbed to his injury at the spot and the handyman-cum-helper was seriously injured on his persons. And the aforesaid Mini-Tata was badly damaged and the frontal part of the Shaktiman was also damaged. The injured handyman was evacuated at District Hospital, Kangpokpi and later referred to Senapati Hospital for further medical treatment. The cause of the incident was unknown.

Hence, a Suo-Moto case under FIR No.104(8)2023 KPI-PS U/S 279/338/427/304-A IPC was registered for investigation.
