With due respect, I have the honour to report the following few lines that, on 5th May, 2023 at around 7:30 pm, some unknown armed miscreants suspected to be Kuki militants and kuki rioters burned down/torch many houses and looted many valuable properties of Meitei houses at persain village, Kalapahar Kangpokpi district, PS Kangpokpi district. In that, Kuki arms Militants and kuki rioters have burnt down my house and looted my household properties like furniture items, kitchen items, utensil items, clothing, and electronics items, Cash, Jewelry and important documents. The approximate value of looted properties are estimated at Rs. 15,00,000/- (fifteen lakh) approximately.

Regarding the matters I couldn't able to report till date due to the present situation in the states. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
