H00298065, Chassis no. HAR3DXSUA03017680 which was used for PMGSY road construction work at IT road near Geljang Village Kangpokpi District, Manipur was stolen away by some unknown armed miscreant suspected to be Kuki militants. The approximate value of the JCB is about 28 lakhs. The whereabouts of the said JCB could not be Ascertain till date despite hectic effort to find out the said JCB. It could not be reported the matter timely due to prevailing communal Crisis in the state.
