Today i.e., on 15/02/2023 at around 12:10 PM, a joint team of Kangpokpi District Police, NAB, MA/MRB, and Forest Department Kangpokpi District, SDM Chungtaw Block, Kangpokpi District, numbering about 98 personnel (23N/1) supervised by Insp. B. Lunthang Vaiphei OC of Saikul-PS under the supervision of Shri Th. Vicksamjet Singh MPS, SP/CP, carried out a mass destruction of illegal poppy plants cultivation in the hill ranges of Tophang (M. Ngambui) Village, under Chungtaw Sub-Division, Kangpokpi District, Manipur about 25 kms North from Saikul Police Station in which illegal poppy plantation of land covering about 5 (five) acres were totally destroyed.
